Throughout the 20-21 school year, PAC held various virtual meetings to gather stakeholder input. Parents and staff were surveyed with a strategic plan survey in February and an LCAP survey in April. The Parent Advisory Committee and the Strategic Plan Committee, both comprised of staff and parents, met to review the data and make recommendations on priorities for the 21-22 school year.

A description of how students will be identified and the needs of students will be assessed.

Placer Academy utilizes the NWEA MAP assessment to assess and identify students in grades 2-8 in reading and math. There are three assessment windows per year – fall, winter, spring. The fall assessment (administered in week 3) coupled with formative assessments used by the teacher will be used to identify students needing additional supports and/or supplemental services. Regularly scheduled staff meetings and Student Support Team meetings are held to monitor student progress and reassess services provided.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents will be notified of the opportunities for supplemental instruction and support directly as students are identified through assessment, teacher recommendation, and/or the SST process. Additionally, the school will solicit parent input regarding any social-emotional needs for students that would benefit from additional support on campus.

A description of the LEA's plan to provide supplemental instruction and support.

Extending Instructional Learning Time:

-After school homework/review support will be available to students that are identified by their homeroom teachers. Support will be provided by instructional aides.

Accelerated Progress:

-Strategic intervention will be provided to students identified through school-wide assessments as having learning loss or learning gaps.

-The school will provide instructional aide time to support learning in the classroom. These individuals will work with small groups of students to support learning goals as detailed through school-wide and grade level assessments.

-The school will provide individualized instruction through various instructional platforms including but not limited to Lexia, CAPIT, Aleks, Zearn, and RAZ Kids.

Integrated Student Supports:

-Identify and provide opportunities for site-based school counseling services for student in need who currently do not qualify through an IEP.

-Identify and purchase an integrated school-wide SEL curriculum.

Community Learning Hub:

-Provide internet hotspots for families to access curriculum at home.

-Provide loaner technology devices for families that do not have access to a device at home.

Additional Academic Services:

-The school will continue to use NWEA Measures of Academic Progress (reading and math), ESGI (phonemic awareness and phonics) and Edulastic (math) to continually monitor student progress and plan appropriate instructional strategies.

Training for Staff:

-Provide professional development to support differentiation and implementation strategies to address learning loss and social-emotional health for students.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The majority of the ELO grant funds will be used to assess learning loss and social-emotional needs. Those strategies proven during the 2021-22 school year to be most effective with students will be extended during the 2022-23 school year using ESSER funds. ELO grant funds are included in the District's Local Control and Accountability Plan, where specifically aligned to each goal and action.

Placer Academy created plans with stakeholder input to address COVID-19 related needs, including academic, behavioral and social-emotional supports, and is utilizing ESSER funds and ELO grant funds to meet the needs of students. The funding sources used for each component of the school plan are dependent upon the fiscal requirements of each source.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
