



Agreement to Transport Students Under Education Code 35330

I am a parent/guardian of a student of Placer Academy Charter. I am willing to transport students in my privately owned vehicle to and from school activities off campus on the following terms:

1. I currently have and will continue to maintain liability insurance coverage on the vehicle used to transport PAC students in the amount of not less than \$100,000 per individual, \$300,000 total injury to persons, and \$50,000 damage to property per accident. My insurance is with:

2. I currently have a valid California Driver's License # _____ which expires on _____, and that Driver's License is not suspended, or pending possible suspension or revocation. I will immediately report to the school office should either of the foregoing events occur.
3. I am at least 21 (twenty one) years of age and the vehicle which I will use to transport PAC students will be, to the best of my knowledge, in safe operating condition, and I will operate my vehicle in accordance with the laws of the State of California while transporting PAC students to and from school activities off campus.
4. I will carry only the number of passengers for which your vehicle was designed. If you have a pickup truck, only carry as many as can safely sit in the passenger compartment.
5. I will require each passenger to use an appropriate child passenger restraint system (child car or booster seat) or safety belt in accordance with law.
6. I will not smoke a pipe, cigar, cigarette, e-cigarette, or vape while there are minors in the vehicle as required by law. **NOTE: SB7 (CH.425, Statutes of 2007) added Health and Safety Code 118947-118949 to make it unlawful for a person to smoke in a motor vehicle in which there is a minor.**
7. I will check the safety of my vehicle: tires, brakes, lights, horns, suspension, safety belts, etc.
8. I will obey all traffic laws and take the most direct route to the destination or event without unnecessary stops.
9. I will not use a cellphone while driving as required by law.
10. I understand that unless mileage expense has been previously agreed to by PAC, I will be operating my vehicle at my own expense.

11. I also understand the Education Code 35330 applies to me when I drive my vehicle on a school field trip. It reads in part "...All persons making the field trip or excursion shall be deemed to have waived all claims against the school or District or the State of California for injury, accident, illness, or death occurring during or by reason of the field trip or excursion..." (A full copy of Education Code 35330 is available from the school office or by calling (916) 259-1688.)

I understand that this means that PAC or the District is not liable for any accident or injury, which I may be involved in or cause.

In case of emergency, keep all students together and call 911 and the school office at (916)259-1688.

I have read the above information and I am aware of the policy and my responsibilities when transporting students. I certify that I have received and will abide by the drive instructions provided by Placer Academy Charter.

I have provided the school with a copy of my Driver's License and a copy of my auto insurance with this form.
