Throughout the 2020-2021 school year, PAC held various virtual town hall meetings to gather stakeholder input. Parents and staff were surveyed with a strategic plan survey in February and an LCAP survey in April. Additionally, a weekly meeting was held with PCOE, the Placer Superintendents, and the Placer County Health Department officials to ensure we were able to bring back students safely during the COVID pandemic. This helped the team create the Health and Safety Plan.

The Strategic Plan Committee, comprised of certificated staff, classified staff, and parents, met bi-monthly during the 2020-2021 school year to develop 6 strategic priorities and a 5-year plan around those priorities. The Parent Advisory Committee, comprised of

staff and parents and led by the Vice Principal, met to review the LCAP survey data and make recommendations on LCAP priorities for the 2021-2022 school year.

Feedback from the community engagement strategies described above was incorporated into the development of the specific strategic priorities and the key performance indicators for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the LCAP remained consistent with current feedback, including a commitment to in-person learning, personalized instruction, small group support for math and reading, maintaining strong SEL programs, enrichment opportunities, and high-quality instruction. The services and opportunities for the students as described in the ESSER III plan incorporate this feedback and continue to build on the Placer Academy Strategic Plan and the LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social, emotional, and mental health needs of all students. Placer Academy Charter engaged with The ARC of Placer County on October 5th via phone call.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
